Tuition

Tuition for the program is \$1100, payable in full no later than September 2009, unless other arrangements are made prior to this date through direct written application to the Board of Directors. Employer/Organization sponsorship is encouraged, but Employer/Organization sponsorship is limited to \$1000, with the remaining \$100 paid by the program participant. Financial aid is available for those accepted participants who demonstrate need. Please attach a brief 100-word statement explaining the basis for your need. Financial aid varies from 25 percent to 100 percent of the tuition cost. Leadership Burbank is committed to having a broad cross-section of the community participate, and no applicant selected to participate in the program will be turned away due to financial need. Any applicant who is granted financial aid, in excess of 50 percent, is required to pay \$50.00 per missed session to Leadership Burbank as a partial reimbursement of such financial aid and to encourage full attendance.

Leadership Burbank consists of nine classes held typically one Friday each month over a nine-month period (September – May). In addition to an orientation evening in September, students take part in an additional half-day Saturday class in October for a Simulated Society session, and one additional Saturday for a local class retreat in February. Each Friday session runs from 8:00 a.m. – 4:30 p.m., and includes lunch. Pre-class reading, interviews, and observation visits are assigned each month to be completed both independently and in pairs or teams. From January through May, additional out of class time is required for work on a class project. A graduation ceremony will be held in May. Each program participant must attend at least 7 of the 9 classes and the retreat to graduate from the program (unless special permission is granted in advance by the Leadership Burbank Board of Directors).
